- 1. Planning Phase: Choose Lead/Co-Leads for Program Review, Kick-Off Meeting, Communication to Faculty, Plan Data Gathering Activities, Write Questions and Surveys
- 2. Data Gathering and Analysis Phase: Institutional Research Package Data, Gather Feedback from Students, Faculty, Alumni, Employers, Consolidate Data, Analyze Data
- 3. Self-Study Phase: Faculty Orientation Meeting, Discuss Components, Write Draft Version, Share Draft Version with Faculty, Submit Final to Dean and CTLI to send to External Team
- 4. External Review Phase: Nominate and Invite Reviewers, Organize Schedule, External Review Team On-Site or Virtual Visit, Write and Submit Report to Dean to Share with Faculty
- 5. Final Report and Action Phase: Reflect on Self-Study, Data, and External Review Report, Write Final Report and Action Plan, Submit Final to Dean for Approval to VPA to EdCo for info
- 6. One-Year Follow-Up Report Phase: Undertake Action Items, Discuss Progress with Faculty, Submit One-Year Follow-Up Report to Dean, Dean submits to VPA
- 7. Ongoing Curriculum Renewal Phase: Undertake Ongoing Feedback Gathering from Students, Faculty, Alumni, Employers, Gather Learning Outcome Evidence, Do Action Plan Items

Note: • There are seven phases that are part of the Curriculum Renewal and Program Review process. This process repeats every seven years.

• The first five phases of program review take about one academic year (~10 months) with a follow-up report a year later, at the end of Year 2.

- 6. One-Year Follow-Up Report Phase: Undertake Action Items, Discuss Progress with Faculty, Submit One-Year Follow-Up Report to Dean, Dean submits to VPA
- 7. Ongoing Curriculum Renewal Phase: Undertake Ongoing Feedback Gathering from Students, Faculty, Alumni, Employers, Gather Learning Outcome Evidence, Do Action Plan Items

Note: • There are seven phases that are part of the Curriculum Renewal and Program Review process. This process repeats every seven years.

• The first five phases of program review can take place over two years. A year later there is a follow-up report due at end of Year 3.
